OPINION PER CURIAM: 1 Keith Smith challenges his conviction of possession of a firearm by a convicted felon in violation of 18 U.S.C. Sec. 922(g)(1). He contends that the district court erred by denying his motion to suppress evidence. We affirm. I. 2 On February 3, 1994, at about 7:55 p.m., Officer Dykes of the Baltimore City Police Department stopped Smith, a passenger in a car, for speeding and a defective brake light. The district court made the following findings of fact. Officer Dykes asked Smith to step out of the car. Dykes noticed a plastic bag in Smith's coat pocket. Dykes asked for and received permission to search Smith. Dykes searched the bag and found a loaded revolver. 3 The parties stipulated that Smith had a prior felony conviction and that the firearm had traveled in interstate commerce. The court found that the stop was lawful under the Fourth Amendment. The court found that the officer had reasonable suspicion to detain Smith and search his
